"Ragging is a disorderly conduct whether by words spoken or written or by an act which has the effect of teasing ,treating or handling rudely any student ,indulging in rowdy or undisciplined activities which cause or is likely to cause annoyance , hardship or psychological harm or to raise fear or apprehension thereof in a fresher or a junior student and which has the effect of

causing or generating a sense of shame or embarrassment so as to adversely effect the psyche

### PENALTY FOR RAGGING

No person who is a student of an educational institution shall commit ragging. Supreme Court of india has ordered that "If any incident of ragging comes to the notice of the authority, the concerned student shall be given liberty to explain and if his/her explanation is not found Satisfactory, the authority should expel him/her from the Institution.
