Subject: Government Dental College, Ahmedabad - Central Government Permission for admitting 5th batch of students in the BDS Course with increased admission capacity from 50 to 100 - Reg.

Sir,

In continuation of this Ministry's letter of even No. dated 01-08-2003, I am directed to say that the Dental Council of India vide letter No. DE-3(8)-2004/7136 dated 20-09-2004 has recommended to the Government that pending inspection of the Government Dental College, Ahmedabad for recognition of the BDS degree with increased seat capacity from 50 to 100, the College may be permitted to admit 5th batch of students with the increased capacity subject to the condition that the admissions in the year 2005-06 will be made only after the recognition of the degree with increased seat capacity.

2 This recommendation of the DCI has been considered in this Ministry and it has been decided to convey the permission of the Central Government to admit 5th batch of students in the BDS Course with increased admission capacity from 50 to 100 in the subject dental college during the academic session 2004-05 subject to the condition that the admissions with increased capacity in the year 2005-06 will be made only after the recognition of the degree with increased admission capacity.

3 Further, the admissions should be made strictly in accordance with the guidelines issued by the Central Government on 14.5.2003 pursuant to the direction of the Hon'ble Supreme Court of India in Madhu Singh Case.

4 Admissions made in violation of the above conditions will be treated as irregular and action under Section 10B of the Dentists (Amendment) Act, 1993 will be initiated.
