This Memorandum of Understanding (MOU) is entered into by and between PRAJ METALLURGICAL LABORATORY, PUNE and GOVT DENTAL COLLEGE & HOSPITAL, AHMEDABAD Wherein both partner institutions agree on co-operation in research collaborations and student and faculty exchange that would be mutually beneficial towards common goals and drive towards academic excellence. The area of co-operation is focused towards identifying common areas of research and innovations. Such interaction may include cooperation in a variety of joint academic and educational activities such as:

The first party has approached the second party for utilizing the facilities laboratory for undertaking testing facility in the field of Orthodontics, Prosthodontics, Endodontics, and Periodontics.

The Principal, Government Dental College and Hospital, Ahmedabad and Chairperson, PRAJ Metallurgical Laboratory, Pune, will mutually coordinate and oversee the implementation of this agreement.

**NOW THE MEMORANDUM OF UNDERSTANDING WITNESSETH AS UNDER:**

- A joint committee comprising of designed staff members from both parties' explorers' newer opportunities for further research in the field of dental sciences and associated medical subjects. The joint committee also decides regarding streaming of the funds for the research projects with the consent of both parties.
- The First party agrees to provide access to PRAJ Metallurgical Laboratory, Pune for the use of required samples with all relevant details to students and staff members.
- PRAJ Metallurgical Laboratory, Pune will use all the samples and relevant information provided by the First party for conducting research.
- The information about samples and the results are the property of the both parties.
- The information about the samples and the results are not allowed to be transferred to any other party without the consent of the First party.



- All credentials arising out of the research work undertaken under this MoU will appropriately be shared by both the parties as decided by the joint committee.
- The expenditure for all post-graduate projects will be borne by the principal investigator of first party. (Government Dental College and Hospital, Ahmedabad).
- Both the parties can extend the period of MoU upon mutually agreed terms and conditions.
- Both the parties can take up projects individually without the consent of the other party.
- The First party is permitted to access all the details on the progress of the study data and results on the joint studies or projects undertaken under this venture.
- The Second party, if feasible, shall submit a progress report at periodical intervals i.e. once in three months to First party.
- Both the parties will put all efforts inviting grants for various research projects from funding sources.
- The MoU is for a period of ten years from the date of signing and can be renewed with mutual consent.

Subject: Pilot project on "Pit & Fissure Sealant application" under National Oral Health Program (NOHP)

Madam/Sir,

I am directed to say that, National Oral Health Program (NOHP) is a new initiative by Government of India in the 12<sup>th</sup> Plan from FY2014-15 to strengthen the Oral Health care delivery in the country. Under the central component of NOHP, Ministry of Health & Family Welfare has taken an initiative for applying "Pit & Fissure Sealant" in permanent molars as a pilot project to assess the feasibility, so that it can be adapted as a caries preventive modality in the existing public health facilities in future.

In India about 50-60% of the children of school going age are affected by Dental caries which leads to expensive dental treatment, pain and sometimes loss of tooth in advanced stages. Therefore, this has got significant morbidity and adds burden towards health care mainly among the people from low socio economic strata. About 90% of tooth decay (dental caries) occurs in the pit and fissures of permanent posterior Teeth. Permanent molars are at highest risk of developing cavity (Dental Caries) within 2-2.5 years of eruption into oral environment. Dental Sealants are composite resin materials (Something like opaque plastic) that can be applied to the pit and fissures (Developmental Grooves) on the occlusal (Chewing) surface of tooth. It is a completely noninvasive, safe, reliable & proven procedure globally to prevent initiation of dental cavities and has been adapted by many developed and developing nations as a part of school/community health program. It prevents initiation and arrest progression of tooth decay by providing a physical barrier against micro organisms and food particles that gets collected on the chewing surface.

The following Government Dental Colleges under the state administration have been selected to carry out this task:

- i. Maulana Azad Institute of Dental Sciences, New Delhi
- ii. Faculty of Dentistry, KGMU, Lucknow.
- iii. SCB Dental College, Cuttack
- iv. Government Dental College, Ahmadabad
- v. Government Dental College, Bangalore
- vi. Government Dental College, Chennai
- vii. Government Dental College, Hyderabad
- viii. Regional Dental College, Guwahati

Apart from the above Government Dental Colleges, Dental Departments of two autonomous institutions under MoHFW have also been selected for the above said work:

- i. Oral Health Sciences center, PGIMER, Chandigarh
- ii. Department of Dentistry, RIMS, Imphal

The selected institutions are requested to utilise the existing interns, Post Graduate students in the Dept. of Public Health Dentistry for this purpose. In case of inadequate staff in the aforesaid department, alternative arrangements may be made by involving other specialties. MoHFW has kept a target of sealing 5000 molars/selected institution in this pilot project for which 100% financial support will be provided not exceeding Rs 7.2 lakh /institution. Grants will be released in two installments, 70% in the beginning after the MoU is signed & 30% after satisfactory progress of the work with interim report after 6 months of release of 1<sup>st</sup> installment. The implementing authority has to submit the Statement of Expenditure (SOE), Audited Utilization Certificate (UC) etc as per provisions under GFR 2005

An MoU & Bank mandate form has been enclosed herewith for signature by your good self, Principal of the selected Dental College or an authorized officer on behalf of Principal, and may be sent back to this ministry along with duly filled bank mandate form of the grantee institution to facilitate the implementation of the project. A one day workshop will be organized in Delhi to discuss and finalise the details regarding implementation of the project which will be communicated soon.

## 1. Preamble

1.1 Whereas Dental Caries is of significant public health importance in India and 50-60% of the younger population are affected by it, leading to morbidity, loss of school hours & significant economic burden on the country directly or indirectly.

1.2 Whereas majority of the caries begins on the developmental irregularities of the teeth present in the occlusal surface (Chewing Surface) of the molars.

1.3 Whereas Pit & Fissure sealant has been a proven, reliable, non invasive procedure that can be carried out on the molars to prevent dental caries beginning in the occlusal surface.

In an attempt to protect the molars from occlusal caries, this pilot project is initiated by MoHFW in collaboration with Government Dental colleges/Autonomous bodies. Now therefore, the signatories to this Memorandum of Understanding (MoU) have agreed as set out herein below:

## 2. Signatories:

2.1 The MoU is being signed between Ministry of Health & Family Welfare, Govt. of India represented by Director/Deputy Secretary looking after the National Oral Health Program, NOHP (hereafter referred to as MoHFW-1<sup>st</sup> Party),

2.2 The State Government [For Govt. Dental Institutions under the ambit of State Administration] represented by Principal Secretary Health & FW (Here after referred to as - 2<sup>nd</sup> Party)

And

2.3 Director/Principal /Head of the department of the implementing institution (hereafter referred to as Coordinator of the project-3<sup>rd</sup> party) on School based sealant program, as per the terms and conditions given below:-

## 3. Duration of the MoU

3.1 This MoU will be operative with effect from date of agreement and will remain in force till one year or till its renewal through mutual agreement.

## 4. Deliverables:

4.1 To complete application of Pit & Fissure sealants in 5000 molars successfully among the 6-14 years age group children within the time period specified above.

## 5. Financing:

5.1 The MoHFW will provide financial support (Rs 7.2 Lakh Max.) to the institution involved for the proposed activity.

5.2 Funding will be for both recurring and non-recurring activities as per following general conditions:

5.2.1 It is presumed that the execution of the work does not create any employer/employee relationship. In this respect, the contractual partner shall be solely responsible for the manner in which the work is carried out. Thus, MoHFW will not be responsible for any loss, accident, damages or injury suffered by any person whatsoever arising in or out of the execution of this work, including travel.

5.2.2 All rights in the work, including ownership of the original work and copyright thereof, shall be vested in MoHFW, which reserves the right (a) to revise the work, (b) to use the work in a different way from that originally envisaged, or (c) to publish or use the work.

5.2.3 If the option, on the face of this agreement, for payment of a fixed sum applies, that sum is payable in the manner provided, subject to proper performance of the work. If the option for payment of a maximum amount applies, the funds shall be used exclusively for the work specified in this agreement and any unspent balance shall be refunded to MoHFW. In this latter case, any financial statement required shall reflect expenditures according to the relevant main categories of expenditure.

5.2.4. If the work is not satisfactorily completed (and, where applicable, delivered) by the date fixed in this agreement and/or if any financial statement required is not satisfactorily submitted to MoHFW in accordance with general condition 5 below, MoHFW may specify an additional period within which this agreement must be satisfactorily performed. Normally, such additional period should be of at least one month duration, unless it is clear from the agreement that it was particularly important that the performance be completed on the date specified, in which case MoHFW may specify a shorter period or refuse to grant any additional period at all. In the event that the work is not satisfactorily completed and delivered on the date fixed and/or if any financial statement required is not satisfactorily submitted to MoHFW in accordance with general condition 5 below, or any additional period granted, MoHFW may rescind this agreement (in addition to the other remedies), subject to an equitable arrangement being made in case of delay caused by force majeure.

5.2.5. The contractual partner shall complete and deliver the work to MoHFW (including any technical report that may be required) by the date fixed in this agreement or any additional period that may be granted by MoHFW under general condition 4 above. Any financial statement required shall be submitted within thirty days thereafter at the latest date. If the payment schedule on the face of this agreement provides for a



final payment upon completion of the work, this final payment shall be made only after satisfactory receipt of all deliverables called for under this agreement, including any technical report and financial statement.

5.2.6. Grants will be released in two installments: 70% in the beginning after the MoU is signed & 30% after satisfactory progress of the work with interim report after 6 months of release of 1<sup>st</sup> installment. The implementing authority has to submit the Statement of Expenditure (SOE), Audited Utilization Certificate (AUC) etc as per provisions under UAR 2005.

#### 6. Penalty Clause:



In case of violation of any of the provisions of this Agreement /MoU by the Grantee Institution the Ministry of Health & Family Welfare will be at liberty to terminate the contract and the concerned institution/State Government will have to refund the entire grant money along with interest.

#### 7. Disputes & Resolution

Any dispute relating to the interpretation or application of this agreement shall, unless amicably settled, be subject to conciliation. In the event of failure of the latter, the dispute shall be referred to Secretary (Health & Family Welfare), Government of India for resolution and his/her decision will be final in the matter. It shall be binding on the state Government & Grantee institution.

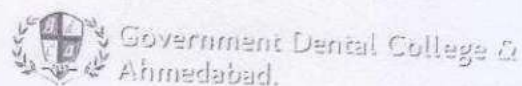

## MEMORANDUM OF UNDERSTANDING

between

*GOVT. DENTAL COLLEGE AND HOSPITAL, AHMEDABAD*

And

*GUJARAT FORENSIC SCIENCES UNIVERSITY, GANDHINAGAR*

This memorandum of Understanding ( MoU) is entered into between **Govt. Dental College and Hospital, Ahmedabad** (hereinafter "GDCHA") and **Gujarat Forensic sciences University , Gandhinagar** ( hereinafter "GFSU") to conduct course in Forensic Odontology under Forensic science Institute. The two institutes shall be referred to collectively as the 'parties' in this memorandum of understanding.

Wherein Govt. Dental College and Hospital Ahmedabad ( hereinafter "GDCHA") is a Government of Gujarat run institute affiliated to Gujarat University and recognized by Dental Council of India ( DCI), New Delhi for the BDS and MDS courses. This institute is located in the New Civil Hospital Campus at Asarwa.

And , Gujarat Forensic Sciences University ( herein after "GFSU" is a superspecialised university; established by the Government of Gujarat state in India, by passing an act no.17 in the legislative Assembly on 28<sup>th</sup> September 2008. It is unique and the first of its kind in the entire world; devoted to only Forensic and Investigative Sciences. The University started functioning from July 2009 onwards and currently runs various Degree/ Diploma / certificate courses in full time / part time /online modes. The GFSU currently comprises of three institutes, namely: Institute of Forensic sciences; Institute of Behavioral Sciences and Institute of Research and development. It is situated at Gandhinagar; the capital of the State of Gujarat, which is a vibrant, industrious, safe and business friendly state in India. In May 2011, the university has been recognized by the University Grants Commission, under Section 22 of the UDG act 1956 as a state University. The University aims to impart 'Education through Investigation' and thus runs in close collaboration with the Directorate of Forensic Science (DFS)- Gujarat state to provide hands-on training to all its students and staff members. DFS- Gujarat state is a state of the art; NABL



accredited; ISO-IEC 17025:2005 certified laboratory, maintaining international standards in term of infrastructure and facilities for Forensic analysis.

The two parties intend to pursue as follows:

1. NAME OF THE COURSE: MSc. IN FORENSIC ODONTOLOGY: Forensic part of the course conducted by GFSU at Gandhinagar and Odontology part by GDCHA at GDCHA.
2. AFFILIATION OF THE COURSE: MSc. in Forensic Odontology will be offered by GFSU.
3. DURATION OF THE COURSE : 2 YEARS ( 4 SEMESTERS : 3 + 1)
4. ELIGIBILITY FOR THIS COURSE: BDS or MDS from a DCI recognized Dental College of India.
5. ADMISSION PROCEDURES: Shall be done by GFSU
6. RECOGNITION OF THE COURSE FROM DCI : Not Applicable.
7. TEACHING STAFFS: Forensic staffs will be provided by GFSU and Dental Staffs shall be provided by GDCHA as decided by the Dean of the Institute; however specialist Dental staffs shall also be recruited on honorary basis as decided by the Dean of the Institute.
8. REMUNERATIONS FOR DENTAL TEACHING STAFFS: Shall be borne by GFSU as per their rules and regulations.
9. PRACICAL SESSIONS: Laboratory setup for Forensic part shall be provided by GFSU and the theory and practical sessions for the Odontology part of the curriculum shall be provided by GDCHA as decided by the Dean of the Institute.
10. NON TEACHING STAFF: Existing non teachinbg staff of GFSU shall be involved.
11. CONDUCTION OF EXAMS: As per the GFSU rules and regulations.
12. RESERVATION DETAILS: The reservation of the seats will be as per the prevalent rules of Government of Gujarat.
13. COURSE CO-ORDINATORS: There shall be two course co-coordinators one from each participating institutes. The Dean of GDCHA will be the course coordinator from the Dental side.




14. FACULTY EXCHANGE: The parties shall endeavor to promote the exchange of faculty members for the advancements of teaching and research in the field of Forensic Odontology.
15. ETHICAL COMMITTEE: The Institutional Ethical Committee (IEC) of GDCHA will provide ethical clearance to research and thesis works of the GFSU students who are enrolled in MSc. Forensic Odontology course only. (subject to the approval from the Ethics committee). The students need to present the synopsis of their proposed work during the IEC meeting which will be held once a year at GDCHA.
16. The parties shall invite faculty from other universities to give lectures or technical training in specific scientific disciplines. The remuneration and other expenses for the external faculty shall be borne by GFSU.
17. GDCHA and GFSU faculty shall engage in active research and training programs by developing grants proposals and securing funds from funding agencies including private foundations.
18. Faculty from the participating institutions who have similar research interests may also have exchange visits. Upon the approval of the participating institutions, faculty may also audit courses at the participating institutions.
19. Both Institutions will work cooperatively to host seminars, workshops and conferences of National and International acclaims to promote research findings and communications in the field of Forensic Odontology.
20. GDCHA and GFSU will obtain external funding to support meetings , workshops and /or conferences
21. While it is assumed that results of any joint research projects shall be jointly published, each institution reserves the right to publish its own results in the course of such research projects. GDCHA and GFSU agree to abide by the policies of any journal in which its joint research may be published including such matter as the public release or availability of data or materials relating to the publication provided that any requirements inconsistent with the terms herein will first be discussed among the researchers of the participating institutions. Authorship will be based on the contributions to the research and in accordance with academic standards and custom.



Results produced in a research project may not be shared with outside individuals or entities prior to publication of the result without the written agreement of both parties.
