Preamble

And (Party 2) Dr M C Tayade , CEO , Medworld Asia International Scientific Forum (MAISF) Nashik , Maharashtra , to be included by mutual consent.

RECOGNIZING mutual interest in research, development, education and technology transfer on a non-commercial basis, and also ,

RECOGNIZING the global nature of today's healthcare development in research and education, industrial and social problems, and the need to address them through cooperation,

HEREBY agree to encourage collaboration according to the terms and conditions set forth in the following articles.

Article 1: Fields of Collaboration

Any mutually agreeable field of healthcare research and education, intentionally only for academic interest.

Article 2: Issue of research grants for scholarly research work.

- 1) Undergraduate /postgraduate / PhD students. - The students should be full time with approved PG guide.
- 2) Research work proposal should be approved by the Institutional Ethics Committee.
- 3) The work should be sending to us in proper format and only after approval may consider by party 2 for grant approval.
- 4) Research work should be carried out in Institutional premises Any extension work , part time work , business related work would not be consider in this article proposal.
- 5) Budget allocation will be sanction by party 2 finance committee only , subject to availability of funds , topic interest etc.

Article 3) Collaboration seminars / workshops/ICT workshops/ IPR workshops/ hands on training etc / National seminars / guest lectures/ National conference etc.

Party I can ask funds for above mentioned activities only through proper channel. No individual requirements would be consider in this article.

Article 4: Research projects

Interested faculty of either institution may initiate joint research projects. Subject to available funding, the Parties will encourage research centers of their respective institutions to initiate and conduct collaborative projects consistent with the other terms and specifications of this agreement. Such joint research projects are to be the subject of definitive project agreements specific to each project and separate from this MOU.

The financial arrangement relating to each joint research project will be in accordance with the specific agreement covering each project.

Party I, is requested to be send each research proposal in separate format be email / courier to us.

Article 5: Intellectual Property, Inventions and Innovations

The terms with respect to title to and exploitation of intellectual property (including trademarks and service marks, copyrights, patents designs and confidential information on the subject of such intellectual property, inventions and

innovations) will be negotiated on a project-by-project basis in the specific research project agreements referred to in Article-3 and broadly governed by the IPR policy of both parties.

Information on research results and scientific materials (reports, articles, books) will be exchanged freely keeping in mind the mutually agreed provision of Intellectual Property Rights.

Article 6: Administration and General Provisions

This MoU shall have an initial duration of five years from the date of signature, unless either party gives a six-month notice of termination. This MoU may be extended further, in five-year increments, by further mutual written agreement

Despite the statements and obligations expressed herein, this MoU is a non-binding expression of the current intentions of the Parties, and neither Party will incur nor be bound to any legal obligations or expense hereunder to the other Party until and unless definitive agreements have been negotiated, approved by the necessary management levels of each Party and executed and delivered by authorized representatives of both Parties.

This MoU is signed subject to approval by the appropriate authorities on both sides.
